



City and County of Sacramento Opt to Renew Clean Energy's Contract to Supply Fuel for Growing Numbers of LNG Refuse Trucks

-- Sacramento's Municipal Fleets of Natural Gas-Powered Refuse Trucks Use One Million-Plus Gallons of Clean-Burning Natural Gas Fuel Annually --

SEAL BEACH, Calif., Jul 28, 2008 (BUSINESS WIRE) -- Clean Energy Fuels Corp. (Nasdaq: CLNE) has been awarded a one-year LNG (liquefied natural gas) supply contract renewal with an option for up to two additional years to provide fuel for the City and County of Sacramento's growing fleets of natural gas-powered refuse trucks. Clean Energy has been supplying LNG fuel under contract to Sacramento's municipal refuse agencies since 2005. Yearly LNG fuel requirements are projected to top one million gallons over the course of the initial contract term.

Serving local residential and business communities in unincorporated areas, Sacramento County currently operates 105 LNG refuse trucks, and has announced plans to add 19 more LNG trucks over the next year. The City of Sacramento's solid waste collection and recycling fleet now includes 61 LNG trucks, with 35 more expected to be deployed within two years.

"We are pleased to continue our supply relationship with the City and County of Sacramento California, where we have provided reliable, cost-effective fueling services to the refuse agencies for the last three years," said James Harger, Clean Energy Senior Vice President. "We understand that reliable fuel supply is a critical factor for refuse agencies and the people they serve, and we have worked successfully in Sacramento to achieve this goal."

Clean Energy has the largest supply of LNG in the western United States, including sourcing contracts with six LNG plants. The Company also operates its own LNG plant near Houston, Texas. When Clean Energy's new California LNG Plant becomes operational in fall 2008, it will provide up to 160,000 gallons of LNG per day and have over 1.5 million gallons of LNG storage. The Company has also announced a long-term contract to purchase LNG from a new plant being built near the California-Arizona border.
